



Overview

Sunley Court is a Retirement Scheme of 40 apartments and is rated "Good" with the Care Quality Commission. Sunley Court began training with GSF with a Regional Training Centre in 2016, received their first Accreditation award in 2020 and Re-accredited in 2023, gaining Platinum status and winning Retirement Village of the year.



Sunley Court provides person centred care including end of life care with an onsite staff team who deliver compassionate care with dignity and compassion. At Sunley Court, all residents are informed about the Gold Standards Framework and the importance of thinking about and planning for the future. Sunley Court has a GSF board in the reception area to promote ACP and its benefits. Before moving to Sunley Court, all residents have a baseline Wellbeing assessment, which includes a discussion on GSF and ACP.

Compassionate Care

At Sunley Court, all our staff have been trained to interact with residents with dignity and respect. Care plans are written considering the needs, preferences and wishes of the resident ensuring they are person centred and also ensures we work in ways that maintains their dignity. All staff have regular supervisions where staff can reflect upon and discuss working practices, systems in place and any action plans are created where needed. A SEA is completed after each death, we find this to be a great way for staff to debrief and reflect on the death and to identify staff that may need extra support when a death has occurred. Staff find this to be of benefit as per the reflective account provided.

Ongoing Learning

Sunley court will continue to update staff's knowledge in end of life care and our care practices. Plans are in place with other organisations to expand knowledge and be recognised as a compassionate community expanding on links with the local community. Staff continue to have annual GSF refreshers and continue to reflect on practices through staff meetings and supervisions.



Sustainability

At Sunley Court, all of our staff have been trained on the Gold Standard Framework during their induction and have updates with our senior team also taking part in a 'what to do and when' workshop. We believe that good communication is key for an efficient service. All staff are invited to attend the monthly coding meetings where all residents would be discussed and coded appropriately. We neighbour a local hospice who we can often turn to for advice and services such as a rapid O/T assessment or for guidance, and also hospitals regarding GSF for a speedy discharge back from hospital when necessary.

The GSF programme continues to underpin Sunley Court's end of life provision and looks forward to continuing its affiliation with GSF to ensure end of life care continues to be at the highest level. Sunley court actively seeks feedback from residents, staff, families and visitors to the Scheme. Feedback is always displayed and acted upon. Residents continue to have input into the vibrant community and we have encouraged regular family meetings which were introduced following Covid restrictions lifting.
